NECTD has 10 buses with available advertising space. Rear and side (curb or driver side) spaces are available for decal only signs. The monthly fee does not include the upfront price of the sign. Six or twelve month agreements are available with a 10% discount offered for sign placements on 2 or more buses.

## **Contract Terms & Conditions**

## 1. <u>Sign Design, Production and Installation</u>

Purchasing Company shall provide at its own expense all design, printing and production services for any signs (only decal permitted), placed on NECTD buses. The advertising space will be limited to the areas noted above (rear of bus, driver side, curb side).

## 2. <u>Bus Assignments</u>

NECTD reserves the right to change, without notice to *Purchasing Company*, the transit service schedule, total service hours, days on which service is provided and service area.

## 3. Approval of Sign Text and Graphic

Text and graphics of all advertising signs shall initially be determined by *Purchasing Company*, with a review copy provided to NECTD prior to installation. NECTD reserves the right to reflect any advertising that in the sole opinion of NECTD, is considered objectionable. In the event of a dispute as to the propriety of any signage, the final determination shall be made by the Executive Director, NECTD.

### 4. <u>Invoice and Payments</u>

Invoices will be mailed out by NECTD quarterly. Payments are due within 30 days.

### 5. End of Contract

At the end of the agreement term, if the contract is not renewed, the sign shall be removed by *Purchasing Company*.

### 6. <u>Agreement Amendment</u>

This agreement may be amended in whole or in part by mutual agreement by NECTD and *Purchasing Company*.
